With Denplan Care you can leave all your worries about costly and unexpected dental bills behind you. Just one monthly payment entitles you to all the routine care and treatment you need to keep your teeth and gums healthy – including examinations, routine treatments and X-rays.

You can also look forward to better long-term oral health because Denplan Care allows your dentist to place a lot of emphasis on preventive dental care. They will give you advice and take positive steps to help you avoid tooth decay and gum disease.

If you ever need dental treatment in a hurry – at any time of the day or night – help is at hand with Denplan's Supplementary Insurance. This accident and emergency cover is automatically included when you become a Denplan Care patient, giving you invaluable peace of mind whether you are away from home, away on business or on holiday abroad.

You'll also have access to Denplan's 24 hour emergency Helpline service which can help you find a dentist wherever you are.

Family group discounts available

Discounts are available if one Direct Debit covers more than one registered Denplan patient receiving treatment at the same practice. The more family members registered, the greater the discount.

How does Denplan Care work?

- Denplan Care is a care contract that allows your dentist to provide ongoing preventive dental care. However, Denplan also arranges on your behalf, mandatory Supplementary Insurance to contribute towards the cost of treatment required as a result of dental accidents or emergencies.
- When you choose to become a Denplan Care patient, your dentist will assess your dental health and agree with you a programme of preventive dental care. Any treatment needed will be carried out before your Denplan Care contract begins.
- You and your dentist then agree a monthly Denplan Care fee that spreads the cost of your ongoing routine and preventive dental care and treatment.
- For the dental care you receive under Denplan Care, you are in contract with your Dentist. For the Supplementary Insurance element you are in contract with Denplan.
- Your payment is collected by Denplan, normally via a monthly Direct Debit. Out of your total monthly payment £1.29 goes towards your Supplementary Insurance.
- You can choose to pay your subscription monthly by Direct Debit, or annually in advance either by Direct Debit, cheque or by credit card to Denplan. Annual payments are calculated on a calendar year basis.
- Please note that a one-off registration fee will be added to your first payment only, to cover initial administration costs. This is equivalent to one month's payment.

Denplan Care offers you:

Routine and preventive dental care from your dentist

- ✓ examinations
 - ✓ X-rays
 - ✓ necessary fillings
 - ✓ hygiene treatment (including scale and polishes)
 - ✓ preventive dental advice and therapy
 - ✓ any necessary extractions
- Major restorative care from your dentist
- ✓ periodontal (gum) treatment
 - ✓ crowns, bridges, dentures, inlays (excluding laboratory fees)
 - ✓ root fillings

Denplan Care does not cover the following:

- ✗ laboratory fees/prescriptions
- ✗ any treatment not specified by the dentist in your Contract
- ✗ referral to a specialist and specialist treatment
- ✗ treatment carried out anywhere other than at your registered dentist except when you need temporary emergency treatment
- ✗ orthodontics, implants, cosmetic treatment
- ✗ sedation fees

As part of Denplan Care you automatically receive Supplementary Insurance which covers:

- ✓ 24 hour worldwide emergency Helpline when away from home
- ✓ dental accident cover (up to £10,000 per incident)
- ✓ temporary emergency dental treatment when away from your own dentist (up to £380 per incident). Total limit payable £760 per calendar year)
- ✓ £60 for every night spent in hospital under the care of a dental or oral/maxillo-facial surgeon
- ✓ up to £12,000 mouth cancer treatment costs for up to 12 months following a positive diagnosis
- ✓ smokers are not excluded from this cover

Your Supplementary Insurance does not cover:

- ✗ permanent treatment in a dental emergency
- ✗ emergency treatment provided by your own dentist or a dentist/specialist acting on your dentist's behalf
- ✗ dental injuries resulting whilst participating in boxing, rugby or hockey (including training) unless appropriate mouth protection is worn
- ✗ mouth cancer diagnosed before joining Denplan or within 90 days after the date you joined Denplan (or for which tests or consultations began within those 90 days)
